Standing Rules – Change to Meeting Place, Day or Time

PURPOSE: To identify how a change to meeting place, day or time is made based on National VFW By-Laws Sec. 205 – Change of Location, Meeting Place, Day or Time.

BACKGROUND: The national By-Laws referenced specify:
“A Post may, after at least fourteen (14) days written notice to the Department Commander and Members of the Post, change its meeting place, appointed day or time upon a majority vote of the members present at a regular or special meeting.”

ACTION: At the September 5, 2019 regular meeting there was an approved by majority vote to automatically change, without the need for additional voting, when a normal meeting day falls on a holiday or during an election year, when the building is used by Waller County, for voting.

1. Normal meeting days are on the 1st Monday of the month with the following times:
 - 5:45 p.m. Pot Luck
 - 6:45 p.m. Post and Auxiliary General Meeting
 - 7:30 p.m. Regular Post and Auxiliary Meetings is separate locations
2. If the 1st Monday of the month falls on a holiday the meeting will change to that Tuesday with same time schedule as above.
3. If it is an election year, Waller County uses the hall as an election pole. They need the hall on Monday (setup) and Tuesday (elections and teardown). For that reason the meeting will change to that Wednesday with the same schedule as above.

The staff meeting will always be the Thursday before the business meeting starting at 6:30 p.m.

The post calendar, found at www.vfw9182.com, reflects all meeting dates based on the above guidelines. Every attempt will be made to keep the calendar current for the entire command year.

The attached page provides the remaining dates of the current command year and should be replaced at the beginning of each command year
